1. General submission

1.1. Bid proposals must reach the CHIETA before the closing date and time as specified above and be deposited in the tender box at the address below. Bidders are urged to sign bid register as confirmation of submission. **NB:** Bidders who will send delivery companies on their behalf to submit, must ensure that the driver sign on the bid register submission register and indicate name of bidding company. Noncompliance will result into disqualification.

1.2. The bidder(s) are required to submit four (4) copies where, one (1) is original and three (3) are duplicates. Pricing Schedule should be in a separate sealed envelope. Each copy must be marked correctly and sealed separately for ease of reference during the evaluation process. Each copy must be indexed and dived with file dividers according to the evaluation Gates stipulated in the bid documents. Non submission will result into disqualification.

2. Payment

- 2.1. CHIETA will pay the fees set out in the final contract according to the table of deliverables and no additional amounts will be payable.
- 2.2. The contractor shall from time to time during the duration of the contract, invoice CHIETA for the services rendered and CHIETA shall pay invoices due within 30 days.
- 2.3. The invoice shall be accompanied by supporting source document(s) containing detailed information, as CHIETA may require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.
- 2.4. No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to CHIETA.
- 2.5. Payment shall be made by bank transfer into the Contractor's bank account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account (CHIETA will make payment only to verified accounts that appear on Central Supplier Database.)
- 2.6. The Contractor shall be responsible for accounting to the appropriate authorities for its income tax, VAT or other moneys required to be paid in terms of the applicable law.

3. Enquiries

- 3.1. Any clarification required by a bidder regarding the meaning or interpretation of the Terms of Reference, is to be requested in writing (e-mail) to CHIETA procurement Unit. A reply will be forwarded within three (3) working days. Telephonic requests for clarification will not be accepted. If appropriate, the clarifying information will be made available to all Bidders by e-mail only. The bid number and the name of the bidder should be mentioned in all correspondence. No enquiries will be attended to on the bid closing date.

1. BID PURPOSE

This document has been prepared to invite service providers with experience in constructing and managing cloud hosting environments to make a proposal based on scope of work laid out herein for a period of five (05) years. This request for proposal (RFP) therefore consists of a detailed description of the service required, the goals to be achieved, the features and elements to be demonstrated in the proposal.

It is expected that the resulting cloud environment will be stable, secure, scalable, easy to manage, and cost-effective to run. This project is open to any service provider with experience in cloud computing. Different Azure services offer a wide range of tools and features that could be used to fulfil the requirements, and any Azure engineers have the expertise to utilize these services cost-effectively. We are also open to any third-party tools or services that could be used in conjunction with an Azure environment to improve functionality, ease of management, or cost-effectiveness. Any third-party services must be well-documented and well supported.

2. PROCUREMENT LEGISLATION

The CHIETA has a detailed evaluation methodology premised on Treasury Regulation 16A3 promulgated under Section 76 of the Public Finance Management Act, 1999 (Act, No. 1 of 1999), the Preferential Procurement Policy Framework Act 2000 (Act, No.5 of 2000): Preferential Procurement Regulations, 2022 and the Broad-Based Black Economic Empowerment Act, 2003 (Act, No. 53 of 2003).

3. TECHNICAL ADMINISTRATIVE ENQUIRIES

4. COUNTER CONDITIONS AND FRONTING

Bidders’ attention is drawn to the fact that amendments to any of the bid conditions or setting of counter conditions by bidders or qualifying any bid conditions will result in the invalidation of such bids.

The Government, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct, or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in bid documents. Should any of the fronting indicators as contained in the guidelines on complex structures and transactions and fronting, issued by the Department of Trade and Industry, be established during such enquiry / investigation, the onus will be on the Bidder / contractor to prove that fronting does not exist. Failure to do so within a period of 14 days from date of notification may invalidate the bid.

5. BID VALIDITY

The period of validity of tender and the withdrawal of offers, after the closing date and time is 120 days

6. SCOPE OF WORK AND TERMS OF REFERENCE

The CHIETA’s current infrastructure is piloted through Microsoft foundations. Our applications are under SQL Servers with Microsoft operating systems. This is also tied to a Microsoft Active directory service which is supported by a two-factor authentication application.

We are looking for a service provider that will migrate our current infrastructure to Azure for a period of five(05) years commencing in April 2025. The infrastructure to be moved is SQL driven applications, Hyper-V infrastructure VMs. The hosting should comply with POPIA, and data should reside within the South African borders.

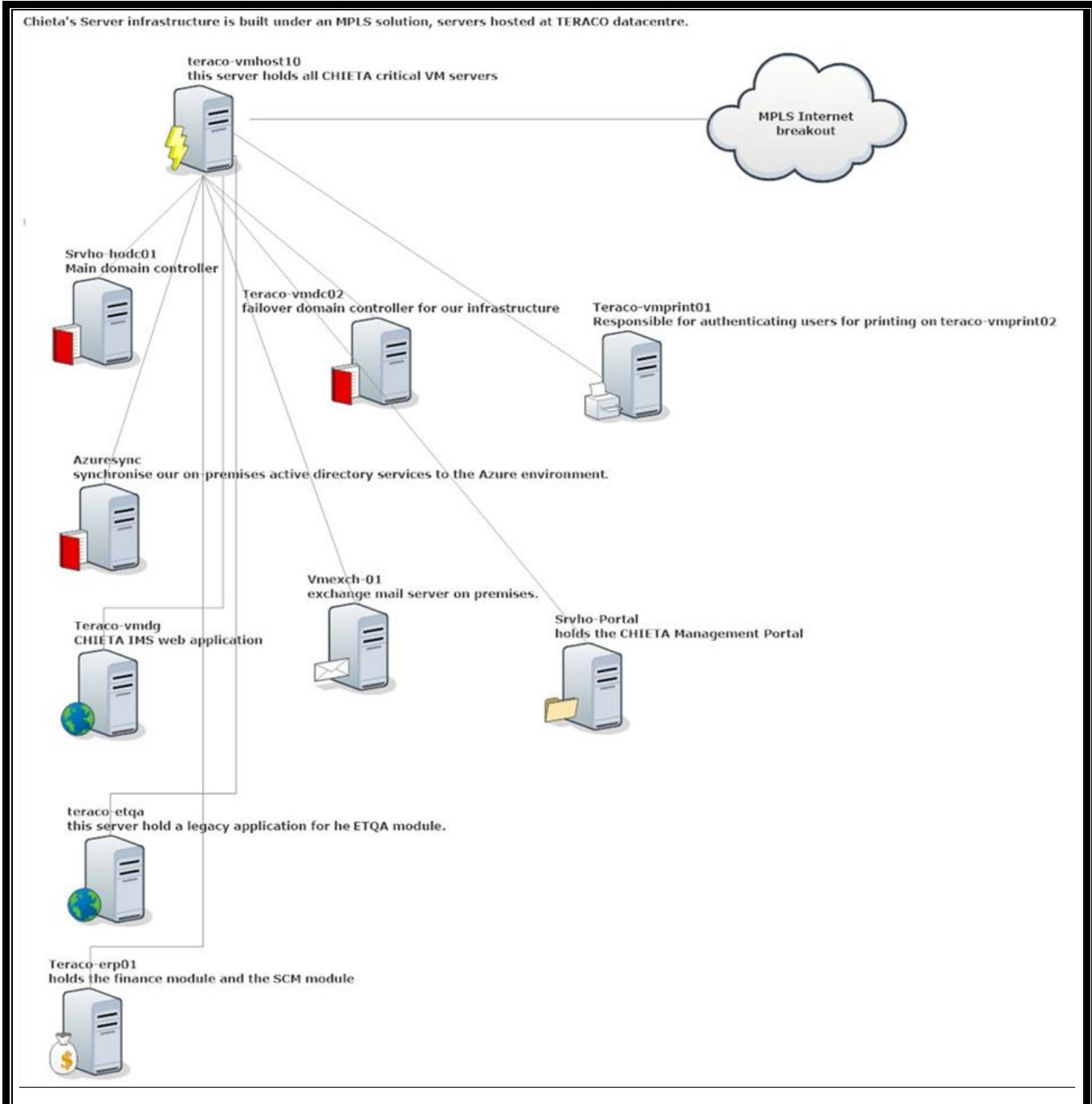

7. EVALUATION AND SELECTION CRITERIA

The CHIETA has set minimum standards (Gates) that bidders must meet to be considered. All bidders' proposals duly lodged as specified in the tender document will be examined to determine compliance with bid requirements and conditions. Bids proposals with obvious deviations from the requirements/conditions will be eliminated from further consideration. Below criteria will be used to assess individual bidders' proposals.

Only evidence from the bidding company will be considered for the evaluation criteria below. Evidence of a sub-contractor that the bidding company intends to subcontract will not be considered unless the bidding company has entered into a valid joint venture agreement signed by both parties.
